

 - 1. The Indian Air Force Educational and cultural society (Name of the Society/Trust/ Company under section8) is a registered society / trust under the Societies Registration Act 1860, vide registration no S/11214 (Name of the Act under which society / trust is registered/section).
 - 2. That the <u>Indian Air Force Educational & Cultural Society (Name of the Society/Trust/Company under section 8) is of Non-Propriety Character.</u>
 - 3. That Air Force School Agra is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
 - 4. That no part of income from the institution is being, and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other persons/ entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to the developmental, depreciation and contingency funds, will be further utilized for promoting the school and extending the clause of education in the same school only.
 - 5. That Air Force School Agra is not paying any charges towards using name motto, logo or any other non- academic activities to any other institution, organization or body.
 - 6. That Air Force School Agra will not open classes under CBSE pattern particularly class IX/X//XI/XII, and will not use CBSE name in any manner without obtaining affiliation.
 - 7. That the Principal and correspondent/Manager of the School Agra have individually gone through the provision contained in the affiliation & examination by laws and the circular issued be the Board from time to time. The School undertakes to abide by the provision contained in the Affiliation & examination by laws, direction issued from time to time and the law of the land.
 - 8. That Air Force School Agra will ensure compliances of all statutory requirements like EPF, ESI and labour laws etc. with respect to the school and staff of the school.
 - 9. That Air Force School Agra will ensure that the building Safety, Fire Safety, Water Safety, Health and Hygiene certificate are being issued or



- 10. That Air Force School Agra will ensure that all required infrastructure is available with the school before starting classes.
- 11. That Air Force School Agra will ensure that sufficient number of qualified teachers as per the provision contained in affiliation bye-laws are available with the school before starting classes.
- 12. That Air Force School Agra will follow the provision related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every, year before start of session without resorting to any hidden charges in the heads of the fee.
- 13. That Air Force School Agra will not coerce any students/parent to buy books/stationery/uniform from any particular shop.
- 14. That Air Force School Agra shall strive to make efforts for conservation of environment.
- 15. That Air Force School Agra will ensure that the school fulfils all essential requirements before applying for affiliation and will fulfil all other condition post affiliation and comply with all the general rules as given in the affiliation bye-laws or notified from time to time.
- 16. That in case affiliation has been with certain condition, the school will not start CBSC pattern classes without submitting a certificate/affidavit to the effect that affiliation conditions contained in affiliation byelaws along with general rules.
- 17. That Air Force School Agra will not be sponsored from the other board.
- 18. That no member of the school Management Committee is related to each other.
